Cancellation & Refund Policy

If a cancellation is requested on or before December 23, 2011, RILA will process a refund in the same manner that the registration payment was made, less a processing fee of 10% per registration. If a cancellation is requested between December 23, 2011 and February 8, 2012, RILA will process a refund in the same manner that the registration payment was made, less a processing fee of 50% per registration. Cancellation requests received on or after February 8, 2012, are non-refundable. Registered attendees may transfer their registrations to another individual from the same company at any time. Business cards and a photo id are required for all on-site registrations, transfers and swaps. All cancellation and transfer requests must be sent in writing. Refund requests for two or more individuals from the same company will be refunded with one check made out to the company.
